1. Welcome & Call to Order

2. Kent County Child Death Review Team Presentation

Carol Paine-McGovern welcomed Robin Bell from the Michigan Public Health Institute and Tracy Cyrus of DeVos Children's Hospital to discuss the efforts of the Kent County Child Death Review Team.

Robin provided the Council with an overview of a Child Death Team's responsibilities. Its primary goal is to study all child deaths within a county and determine their preventability through interventions and/or education. As an example, in Kent County recent data suggests that an unsafe sleeping environment exist for many infants. The Death Review Team then discusses possible ways to educate the public regarding appropriate infant sleeping environments.

Robin noted that Child Death Review Teams exist in all 83 counties of Michigan with staff support from the Public Health Institute. She explained that County Death Team findings are aggregated at the State level to assist policy makers with legislation and/or funding decisions.

- a. Safe Haven Grant The Grant has been submitted and Matthew thanked members of the Council that assisted in this effort.
- b. Prevention Initiative Interviews are scheduled for Friday, February 10 with three firms to conduct the evaluation. Response to the RFP was strong.
- c. Strong Family Safe Children The Executive Committee is following up on the focus groups held this fall and a meeting will be held with the adoption agencies and Adoptive Families Support Network to discuss possible ways to collaborate.
- d. Annual Report to the Board of Commissioners The Annual Report to the Board of Commissioners is scheduled for Thursday, April 27, 2006 at 8:30 a.m.
