### **63rd District Court**

The 63rd District Court is one of five District Courts in the County, but the only District Court funded by the County of Kent. The other District Courts in Kent County are funded by their respective cities.

The District Court is a trial court of limited jurisdiction that has exclusive jurisdiction over the following types of cases: Civil suits involving \$25,000 or less; Adult criminal misdemeanor offenses punishable by up to one year's imprisonment; Civil infractions; Traffic violations; Landlord/tenant disputes; Small claims (involving \$6,000 or less); and Land Contract forfeitures

In addition to its jurisdiction to try adult criminal offenses punishable by up to one year's imprisonment, the district court is the court in which all other adult criminal proceedings begin, regardless of the nature of the offense. In carrying out this function, the district court has jurisdiction to issue arrest and search warrants, set bail and accept bond, conduct misdemeanor and felony arraignments, preside over preliminary examinations for felony and misdemeanor offenses outside its trial jurisdiction, and perform civil marriage ceremonies.




## Percentage of Preliminary Exams Concluded Within 28 Days of Arraignment



## District Court - Total Felony & Extradition Cases Processed (Pending, New & Reopened)




## Total Felony & Extradition Cases Processed (Pending, New & Reopened)










## Percentage of All Probationers Discharged Successfully (vs. Unsuccessful)



## District Court - Total New Probation Cases During Year Per Probation Officer








## Percentage of Abstractable Civil Infractions Violations Submitted to the Secretary


# Total Number of Abstracts Submitted to the Secretary of State

#### **MIDC Implementation**

In a sustained and robust collaborative effort, 63rd District Court worked closely with County Counsel, Sheriff's Office-Corrections, County IT, and district courts in Kent County along with their funding units to develop a coordinated program to appoint attorneys for first appearance arraignments under Michigan Indigent Defense Commission standards. This means that every defendant who is arraigned on any criminal charge in Kent County is offered an appointed attorney for the arraignment hearing. The attorney works to explain the process, advocates on issues of bond and release, and represents the defendant's interests during this key first appearance in the criminal court process. 63rd District Court, Sheriff's Office-Corrections and County Counsel staff acted as lead team for the county-wide collaborative effort, lending subject-matter expertise and maintaining a clear communication bridge between stakeholders. Additionally, 63rd District Court provided hands-on technical and administrative assistance to the other courts and the Kent County Office of the Defender. This program strengthens the administration of justice throughout our county.

Waiver program - Community Impact and Collaboration

During all of March 2019, Kent County 63rd District Court collaborated with 62-B District Court, City of Kentwood, on a joint Warrant, Traffic and Parking Tickets Waiver Program. For those in arrears who paid in full, the Court waived all courtimposed late and warrant fees, except state-mandated license suspension reinstatement fees, which are non-waivable. The Court worked with those unable to pay in full in establishing sustainable payment plans. Collectively, the two courts resolved 281 cases and collected \$70,001.81 in past due fines and costs. Specifically, 63rd District Court collected \$41,927.00 in payments on 179 cases. 62-B District Court saw similar success, collecting \$28,074.81 in payments on 102 cases. This program offered individuals the opportunity to come into compliance with court orders by settling their obligations without further penalty or incarceration, enabling them to move forward with a fresh start.

By joining forces, 63rd District Court; Kent County IT OnBase Team; Kent County Circuit Court Case Management, Personal Protection Office and Friend of the Court; Clerk's Office-Court Division; Probate Court; Prosecutor's Office; and Kent County Sheriff Office promote cost-savings, reduce waste and enhance service to the public.
